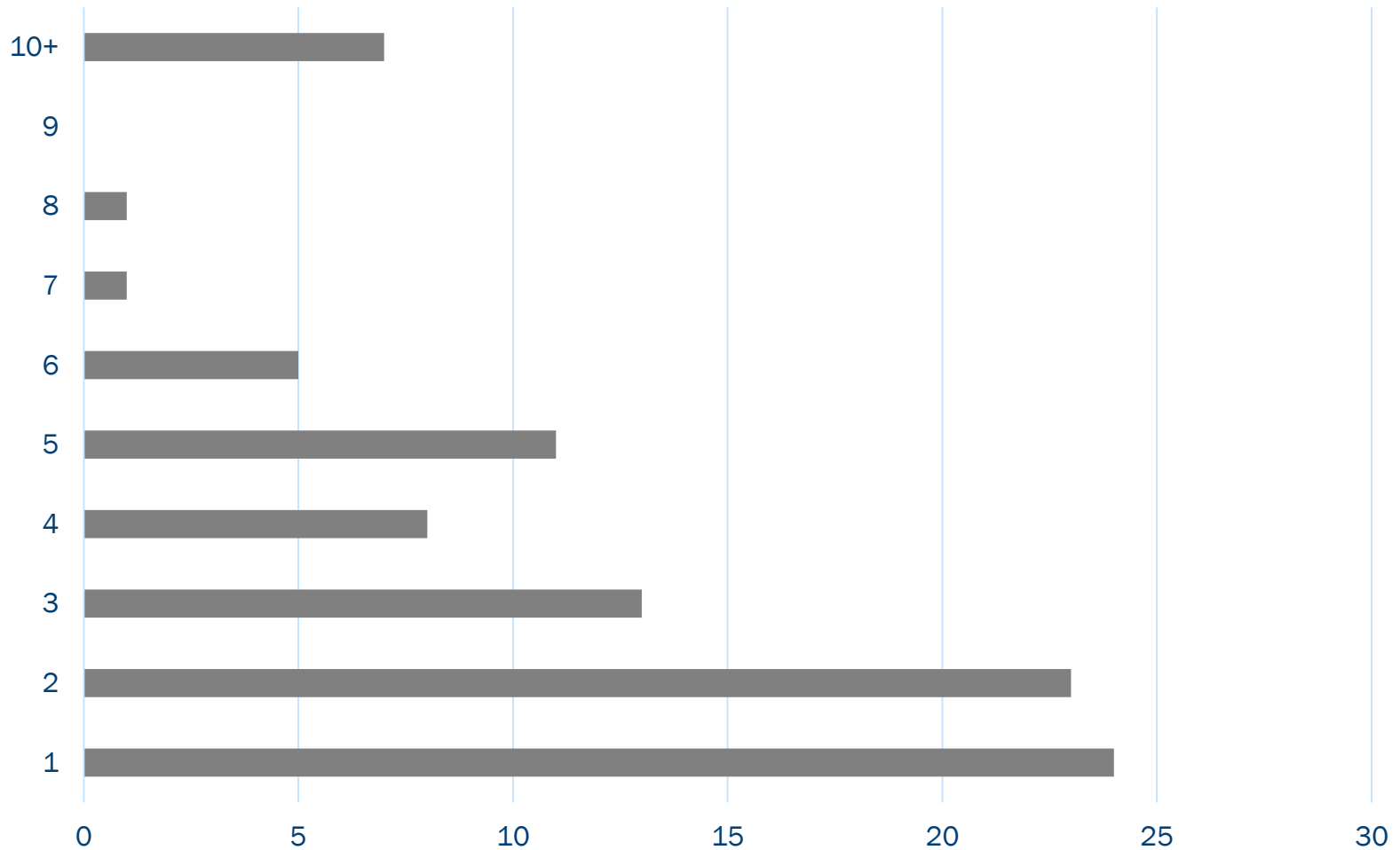

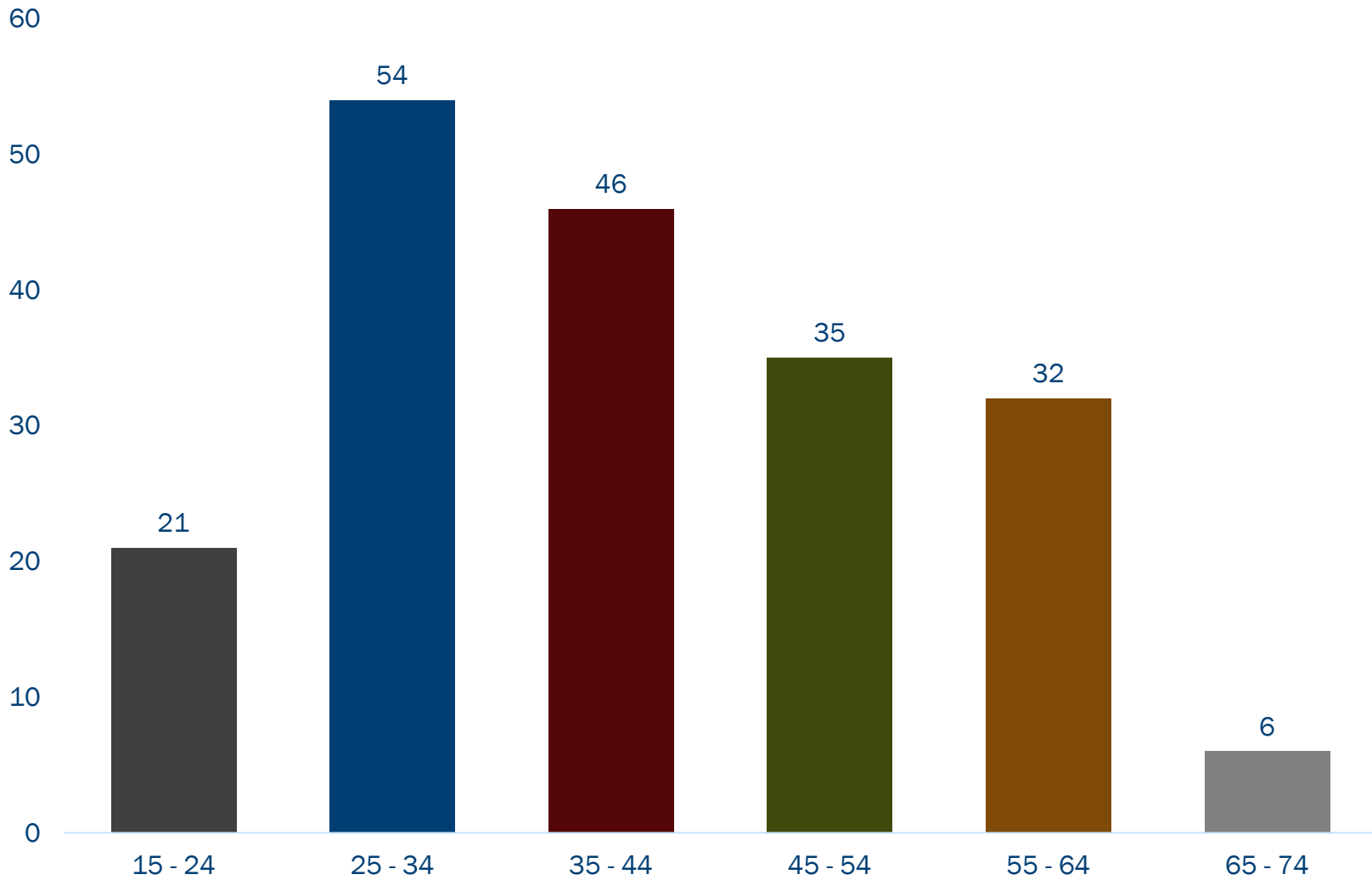

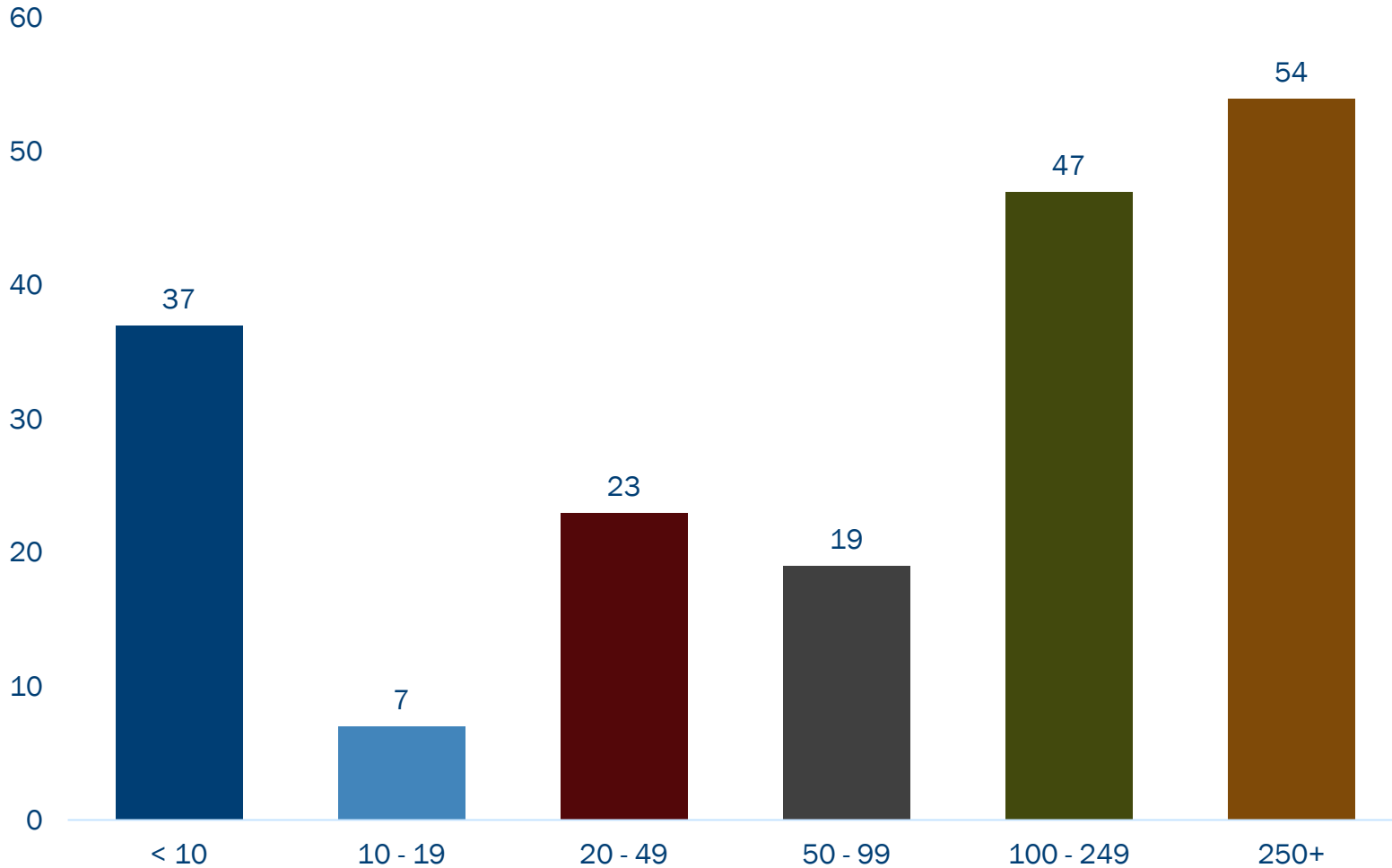
# Number of SafetyFests Previously Attended
